

**Camden Township Regular Meeting**

**April 13, 2022**

The Town Board of the Town of Camden, Carver County, Minnesota met at the Camden Town Hall, April 13, 2022, at 7:30 pm. Members present were Clerk Lisa Goede, clerk-in-training Kayla Coil, Treasurer Denise Zellmann, Supervisors Gerry Goede, David Zellmann, Bill Devine.
